### Types of Solutions on the Market



### **Standalone Awards Management Software**

These solutions are dedicated platforms specifically designed to manage the end-to-end process of awards and recognition programs. They typically include tools for entries, judging, scoring, communication, and reporting. If you do not require any integration with your membership management system, this may be right for you.



### Association Management Software (AMS) with Awards **Modules**

These AMS systems focus on membership management, event management, communications, and financial management, but they also offer awards management capabilities as an optional module. These solutions may not include award solutions with the latest features you will need to properly manage a complex submission and review process with more than 100 entries.





### **Event Management Software with Awards Features**

These event-centric solutions are designed primarily for managing events, but may include some award features, such as submission and judging tools. This basic option will likely not work if your organization has multiple programs, large volumes of submissions, or complex workflows.



### **Customized Solutions**

These solutions are highly customized to your particular needs and are either developed in-house by a large IT staff or through a third-party developer. They typically include automated workflows adapted to your award processes, task management, and tailored forms. Customized solutions may not initially meet industry best-practices, but they can be tailored to address nearly all of your needs — but they are time-consuming and expensive to build, maintain, and upgrade.



### **Integrated Solutions**

This best-of-both-worlds solution combines the advantages of best-in-class awards management that easily integrates with the most popular CRMs, Association Management Systems, and Engagement Management Systems. Advanced **Functionality to Meet Complex Program Needs** 

If your processes are complex and require multiple, distinct submission and review workflows, the software must be able to demonstrate its ability to meet your specific demands.

Integration Capabilities:

It must be able to integrate with popular membership management systems, such as iMIS, NetForum, or Salesforce — as well as payment processing systems, including PayPal and Stripe.

Real-Time Support:

Look for real-time support with experienced, knowledgeable agents — including live chat (not chatbots!), email, and phone support. Also ensure the provider offers training resources, including tutorials, webinars, user guides, etc.

**User-Friendly** Interface:

A user-friendly interface that's easy to navigate for all skill levels, with guided steps for entries, judging, and key processes to minimize errors.

**Flexibility** 

Look for a system that lets you tailor submission forms, judging criteria, and workflows to fit the unique needs of your awards program.

Scalability:

Choose software that can scale based on additional users, submission volume, categories, and programs to meet your growing needs. Also, ensure the provider performs regular updates to keep up with technological advancements.

Reporting and Analytics: You'll need to be able to generate unlimited customized reports on key metrics to monitor progress and evaluate program success.

**Data Security** and Compliance:

Verify the software complies with relevant data protection regulations and adheres to the highest security protocols to protect sensitive information.

Mobile Access:

Your members and nominees will likely access your awards program via their phones at some time, so your software must be offer a responsive design to seamlessly adjusts to the various devices.

Ease of Implementation:

You'll want a vendor with a proven track record in quick and successful implementations and smooth data migrations delivered on-time and on-budget.
